Setting the global agenda

- More than 225 million women worldwide have an unmet need for family planning;
- 2015 marks a critical year in the design of a new global development framework;
- FP2020's success in ensuring high level support and financial commitment to family planning

The changing financing architecture

Modernization of OECD's definition of aid;

- New categories of aid to be expanded;
- Tracking of track financial flows.

Expiry of the World Bank's Reproductive Health Action Plan (RHAP) in 2015;

- The RHAP aimed to improve RH in 57 countries from 2010- 2015.

The Global Financing Facility (GFF) for Reproductive, Maternal, Newborn, Child and Adolescent Health.

- Will be launched in DRC, Ethiopia, Kenya and Tanzania.

Financing for Development Conference is an important contribution to post-2015.

- Emergence of sectoral funds – GFF, climate and Ebola.

Key challenges to FP advocacy

1. Funding must support a comprehensive approach to SRHR and ensure increased funding for commodities.
2. Financing mechanisms, including results-based financing approaches, must be rights-based and equitable.
3. The new financing architecture must deliver additional investment in family planning.

3. Financing mechanisms must have strong accountability and transparency

4. Civil society must participate in the creation of national plans and financing maps, and have a strong role in ensuring accountability.

13 – 17 April	Commission on Population and Development/ New York	-Themed on integrating population issues into sustainable development, including the post-2015 development agenda.
17 – 19 April	World Bank Spring Meetings/ Washington DC	-Finalization of the Global Financing Facility Business Plan.
June	African Union Summit/ Addis Ababa	-Review adoption of key AU Health Policies – including Abuja, Maputo and PMNCH
13- 16 July,	Third International Conference on Financing for Development/ Addis Ababa	-Political agreement on Means of Implementation (MoI) to support the implementation of the post-2015 agenda.
21-23 Sept	70th UN General Assembly/New York	-UN Summit for Adoption of Post-2015 Development Agenda and Beijing +20 Global Leader Commitment meeting.
30 Nov – 1 Dec	Conference of Parties (COP) 21 / Paris	-Achieve a legally binding and universal agreement on climate change.
